

# **PRIVACY STATEMENT**

### What data do are kept and why are needed

Name and date of birth - this are basic information that helps Jing Zhang get to know client.

Address, email address, phone number – Jing Zhang use this as a way of contacting client regarding sessions. Jing Zhang will mainly use the method client first contact but if cannot reach client, will try a different method.

Medical professional's details – If Jing Zhang was worried that client was at risk then may need to contact client's medical professional. Jing Zhang will let client know when/if going to do this.

Session notes – Jing Zhang keep brief notes of session(s) in NHS approved counselling management system.

Audio recordings - Recording is made during session and copy is releases to client. Copy of recording is store in NHS approved counselling management system and deleted after 1 month after session.

### Will I share your data and if I do, who will I share it with and for what purpose?

It is very unlikely that Jing Zhang will share client's data. Jing Zhang will not sell it on or use it for unethical reasons. Jing Zhang may release information to a specific individual or agency if it has been determined that a vulnerable person (child or adult) is at risk; if a client is in imminent danger to themself or others; or if a subpoena of records has been requested. Jing Zhang may also discuss your case during supervision, but I only use client's first name.

### How will I store your data?

Immediately after the work is finished, Jing Zhang transfer the data to NHS approved counselling management system and all physical notes are incinerated. Client's phone number(s) may be kept in Jing Zhang's business mobile phone with client's first name and last initial. Only Jing Zhang will access client's information.



### How long will I store your data for and how will I dispose of it?

Jing Zhang will keep client's details and session notes for the time required by Jing Zhang's insurer (currently 7). After this time, Jing Zhang will destroy any document with personal information. Jing Zhang will delete client's phone number out of mobile phone after 6 months from last session. Jing Zhang will re-enter client's phone number to business phone on next contact of Jing Zhang.
